One cannot have **peace** in a system that profits from **war**.

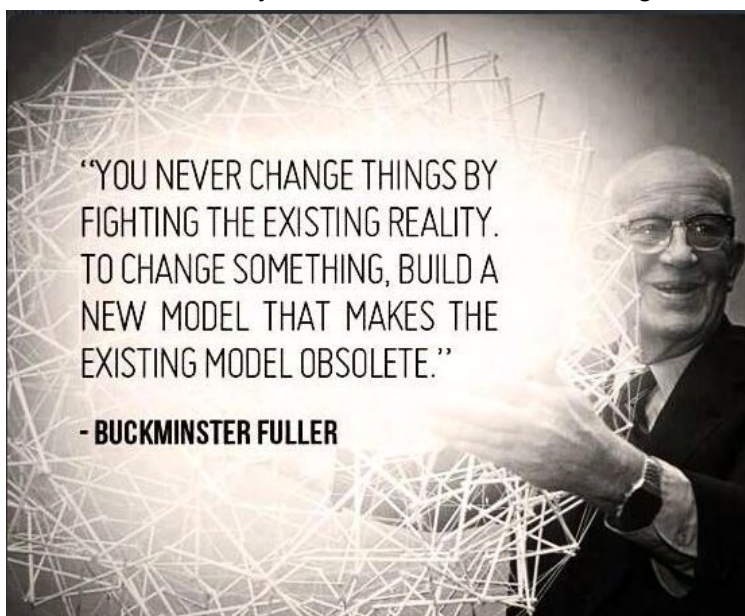
One cannot have **enlightenment** in a system that profits from **ignorance**.

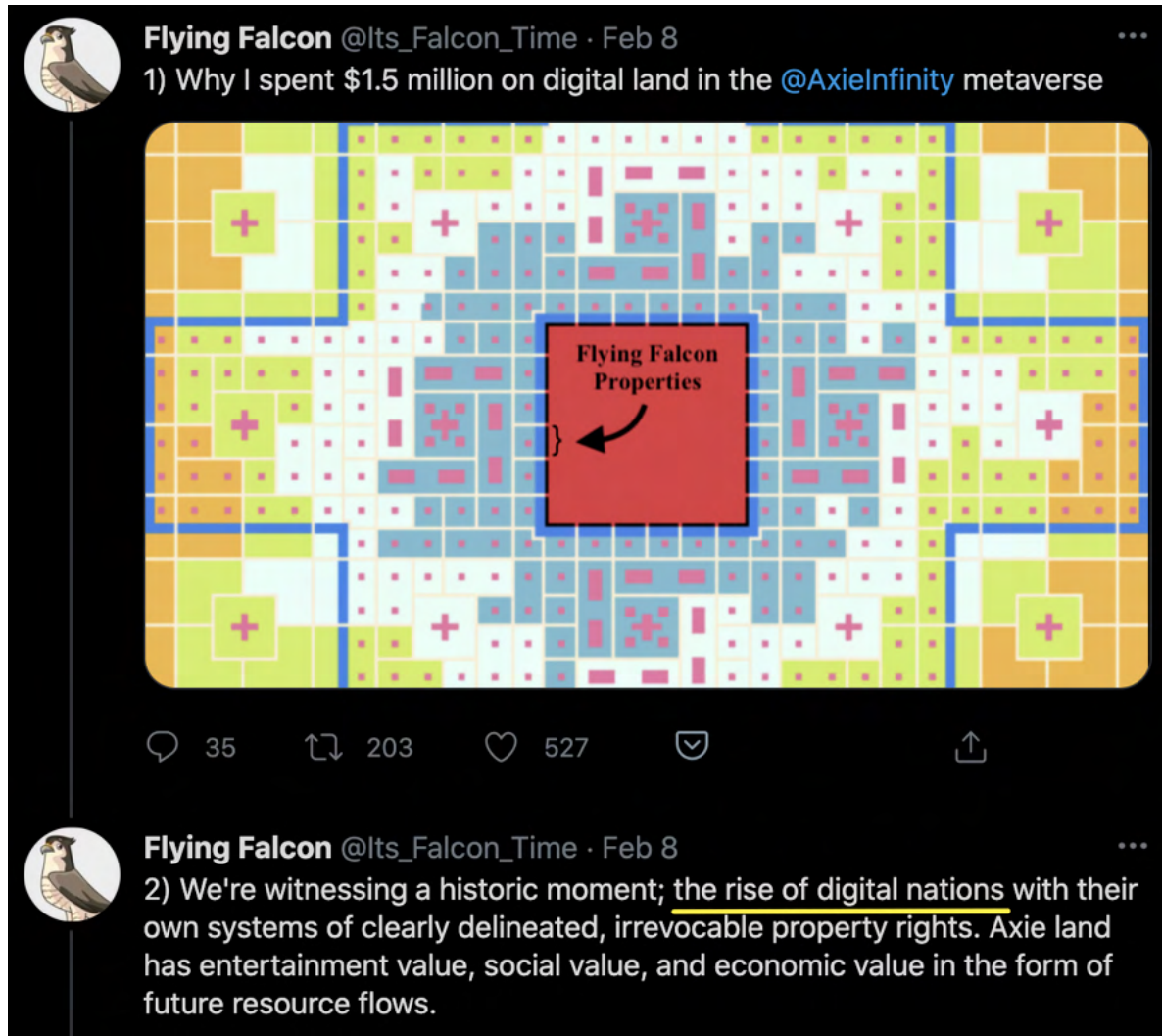

Representative democracy was the best system when information was travelling at the speed of a horse, or ship.

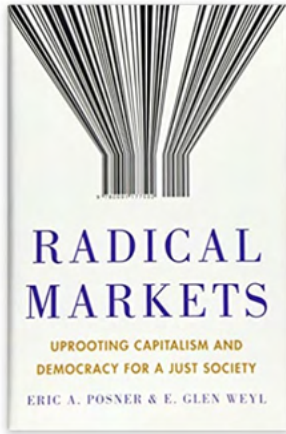
Now we have real time data and communication and we can make decisions in a much better, more informed way.

Climate emergency (incentives related to climate emergency) is my main personal motivation.

Extreme weather, food security, I can afford to pay \$2 rather than \$1 for a sack of rice, but if I was making \$1 per day or less in a sub-saharan Africa so I could get ‘hangry’ (hungry and angry)

I genuinely believe that many people (media, politicians, voters, policy makers) underestimate non-linear changes, tipping points and feedback loops.

Even though I am based in a relatively safe and well-adapted country (United Kingdom) I agree with the prime minister’s recent defence policy review<sup>3</sup> - the instability in one region will affect trade routes and everything in between.

*(speaking of trade routes, maybe you remember that ship that was stuck in the Suez Canal)*

*“As we noted in our last Doomsday Clock statement, the existential threats of nuclear weapons and climate change have intensified in recent years because of a threat multiplier: the continuing corruption of the information ecosphere on which democracy and public decision-making depend.”*

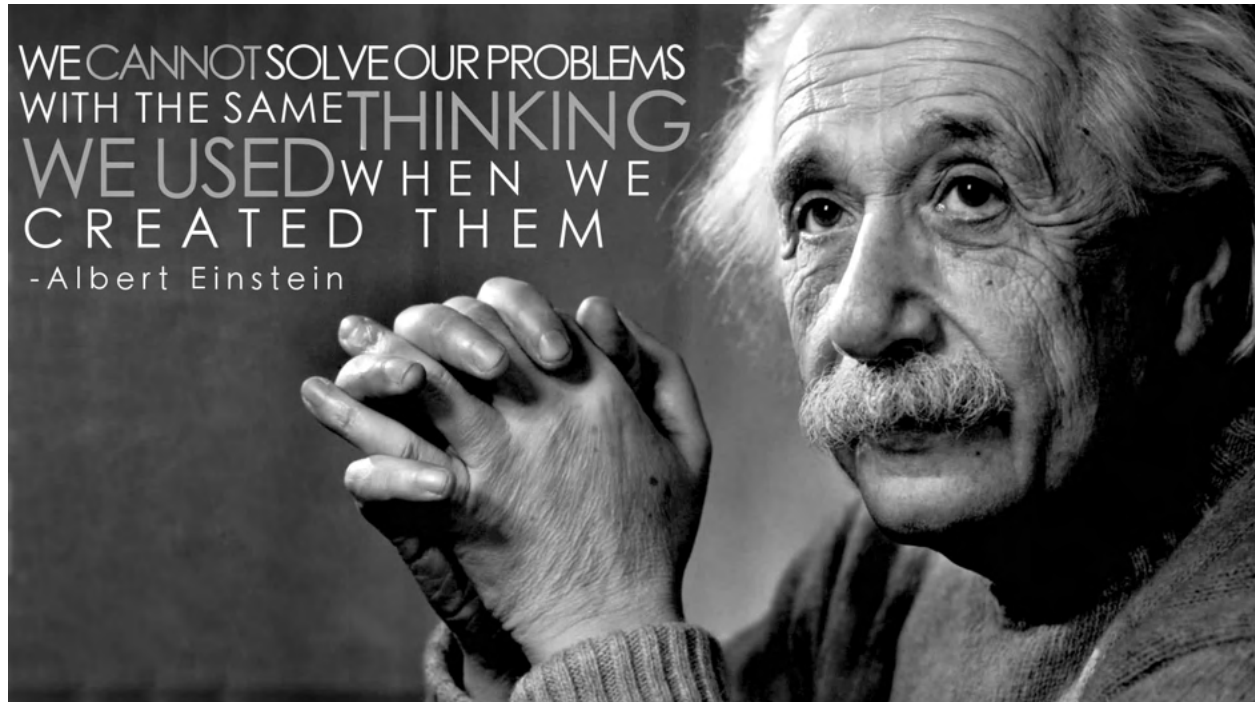

## Planetary Council

The United Nations was created in 1945 after WW2, replacing the League of Nations.

The League of Nations was created in 1920 after WW1, replacing the International Peace Bureau

### **New consensus.**

### **New enforcement.**

*(so that decisions are in fact binding and enforceable)*

**Framework for global cooperation and large infrastructure projects.**  
(with the emphasis on energy, food, and water security)

“war on drugs” and private prison system<sup>9</sup> got out of control.

Putting people in jail for drug-related offences is a low-cost customer acquisition, with pretty high lifetime value - example of an incentive that went terribly wrong.

## Voluntaryism

Everything is voluntary, including taxation.

Paradigm shift (*can win a Nobel Prize in Economics a few years from now*)

From: **“taxation is a theft”**

To: **“monthly subscription for governance services”**

Idea in a nutshell: citizens can voluntarily contribute 2 hours per month of their time to the DAO to receive tokens exchangeable for services of the government.

You can always buy services from the government at the market price, but the subscription is better, less hassle, better price, effectively a “no brainer” to use. It is also fun to do things together while supporting the **Network State Genesis** with your energy.

## Enforcement of blockchain agreements in the physical world

An example: you own NFT that represents ownership of self-driving Tesla that is earning you an income.

Do we have the law enforcement infrastructure across the planet to repossess the vehicle?

How long would it take under the current legal regime for courts to issue a legally binding order and to actually enforce it?

I bet 1 ETH more than 1 year from start to finish, we can put that bet on the blockchain.

It's the same situation as gold and gold mining. The marginal cost of gold mining tends to stay near the price of gold. Gold mining is a waste, but that waste is far less than the utility of having gold available as a medium of exchange.

I think the case will be the same for Bitcoin. The utility of the exchanges made possible by Bitcoin will far exceed the cost of electricity used. Therefore, *not* having Bitcoin would be the net waste.

Directly related to no killing, health and biosphere but important enough to deserve an individual mention.

If we cannot prevent killing, then we can impose an AID: Artificial Insemination Directive.

Artificial insemination is against animal cruelty laws.

Meat itself is still OK, the factory farming is not.

You can grow your own supply, personal liberty, freedom, sovereignty.

## Moratorium on fake news

In the old system it used to be OK - increasing time on site, engagement rate (outragement) at a cost of emotional wellbeing.

Life is our core value, health is important, messing with mental health and wellbeing is uncool.


